At the outset, Mr. Parvinder Singh, Stage coordinator being the host, welcomed the delegates of the Special General Body Meeting, Mr. Parvinder Singh requested Dr. Karan Singh Administrator, Handball Federation of India (HFI), to address the members of the meeting and initiate the proceedings as per agenda.



Administrator, HFI informed the house regarding the Election of Governing Body of Handball Federation of India for the period of 3 years (2022-25) during the present Special General Body Meeting. He said that the Election process is strict as per the National Sports Development Code (NSDC) 2011 & its addendums, HRRS Act, 2012 as well as Memorandum of Association of Handball Federation of India.

The Administrator apprises the house that he was appointed by the District Society of Registrar, Rohtak vide Order no. DIC/RTK/F&S/1363-1367 dated 08.07.2022 for conducting day to day activities and to conduct elections of HFI. Dr. Karan Singh, Administrator, complied with the orders of the District Registrar and discharged his duties w.e.f. 08.07.2022 as per his capabilities. He checked the record of HFI from the office of District Society of Registrar, Rohtak, Further, the administrator decided the date for the elections & fixed the same to be conducted on 14.08.2022 at Circuit House, Delhi-Rohtak Bypass Road, Rohtak, Haryana and finalized the voter list and circulated the same to all the states (units affiliated with HFI). He did not receive any adverse remarks on the said list.

The Administrator informed the house that the Handball Federation of India nominated Mr. Prem Singh Hooda, (Retd). Sports & Youth Affairs Officer, Sonipat, Haryana to conduct the elections of HFI, vide Letter No. AD/ HFI/ 18/ 22, dated 18th July 2022. He gave his consent on 19-07-2022. and The Administrator also requested to The Registrar, Firm & Societies Rohtak to appoint an observer by your office they may be present and vet the proceedings of Election of HFI

Administrator, HFI invited the returning officer Mr. Prem Singh Hooda, to preside the house and start the Election process. He also invited Shri Ishwar Singh Yadav, District Registrar, Firm & Societies, Rohtak, Haryana to the dais.

Mr. Prem Singh Hooda informed the house about the election notification of HFI which was released on 23.07.2022 through email id (ro.hfielection2022@gmail.com) of Returning Officer and released the details of Election Process & Election Schedule.

The notification regarding the venue, time and date of elections along with all the relevant papers & forms inviting nomination of the candidature and withdrawal of the candidature for the representative office bearer's post were duly sent to all the concerned States and he also fixed the dates for receiving the forms fully endorsed by President and secretaries of the State units for the post of President, Senior Vice-president, Vice-president, Secretary-Generals, Joint-Secretaries, Treasurers, Executive members. House was also informed that under the instructions of Hon'ble High Court of Andhra Pradesh vide CWP -25608 of 2022 dated 12.08.2022 a stay has been imposed on the members in the voter list from Andhra Pradesh Handball Association from being part of this meeting thereby the said members were not included in the meeting.
